





Mill Meadow and our guests have a longstanding history of recycling and environmentally friendly waste management and this has saved tons of waste going to landfill over the years.

With the arrival of Covid 19 we have had to take a good look at our practices to ensure they are safe for staff, guests and other visitors to Mill Meadow.

As part of the legal requirement to be Covid Compliant/Secure and in order to reduce the risk of transmission we are required to:

- Reduce contact with guests
- Maintain Social Distancing
- Reduce contact with waste products
- Effectively Manage contaminated waste

In order to achieve the legal standard required it is necessary to introduce new working practices:

- Staff will no longer be able to:
 - o Collect waste and recyclables from individual lodges reduces contact with guests and maintains social distancing
 - Re sort mixed waste onsite to separate recyclables removes contact with contaminated waste
- Guests will now be required to:
 - o Empty all lodge waste bins on departure e.g bathroom, bedroom etc
 - o Wash/clean all items for recycling reduces risk of transmission and helps with vermin control
 - Carefully sort waste and recyclables in accordance with the table below this reduces staff contact
 - o Compress items this reduces volume and the carbon footprint of the transport to recycling centres
 - Take the waste and recycled items to a designated point on departure or Thursday evenings whichever is the sooner. reduces staff contact

General Waste	Anything that cannot be recycled e.g. soiled nappies etc	Mixed waste containing recyclable materials can no longer be resorted on site and therefore will need to be disposed of as hazardous waste and the cost charged to the guest.
